

## Terms and Conditions - Van Rental Agreement

This rental agreement was made and is administered by the Save the World Club charity, UK charity number 1096271, for the purpose of renting out a refrigerated Ford Transit, Registration Number: CP61HZK, Registered to Save the World Club.

This Terms and Conditions must be read in full and signed by both parties.

### Definitions:

The Owner: **Save the World Club**, the charity which owns and administers the Ford Transit CP61HZK

### 1. Rental Qualifications:

- 1.1. The Renter states that they are physically and legally qualified to operate the above described vehicle in the United Kingdom;
- 1.2. The Renter declares that they and all mentioned drivers are 25 years of age or older;
- 1.3. The Renter agrees to use the vehicle's storage space for transporting food only;
  - 1.3.1. Heavy objects such as furniture and appliances can severely damage in walls and insulation of the vehicle
- 1.4. The Renter is responsible for any and all speeding fines and/or any other traffic violations that occur while the vehicle is in their possession.

- 3.1. The rented vehicle shall not be used to carry passengers or property for hire;
- 3.2. The rented vehicle shall not be used to carry passengers other than in the vehicle's designated passenger seats in the cab;
- 3.3. The rented vehicle shall not be used for towing and pushing other vehicles, objects, or trailers without the permission of The Owner;
- 3.4. The rented vehicle shall not be used to be entered in any competition or race;

- 3.5. The rented vehicle shall not be used to transport or carry out any illegal goods or dealings;
- 3.6. The Renter shall not operate the vehicle in any negligent manner and agrees to follow all traffic laws and code.
- 3.7. The vehicle shall not be operated by anyone else that is not mentioned on this agreement

**4. Insurance:**

- 4.1. The Renter hereby agrees that they are fully responsible to cover the first £250 deductible in the event of an accident.
- 4.2. The Renter agrees that they are fully responsible for a replacement vehicle, or the hiring fee of one, should an accident occur until the rental vehicle is serviced, repaired, or permanently replaced
